

隱私權政策及個資法保護聲明

四、 個人資料蒐集之類別

依據法務部頒佈之「個人資料保護法之特定目的及個人資料之類別」，本公司將蒐集、處理、利用您個人資料之種類列示如下：

- (一) C○○一辨識個人者。(例如：姓名、職稱、住址、工作地址、住家電話號碼、行動電話、通訊及戶籍地址、電子郵遞地址及其他任何可辨識資料本人者等。)
- (二) C○○二辨識財務者。(例如：金融機構帳戶之號碼與姓名、信用卡或簽帳卡之號碼、個人之其他號碼或帳戶等。)
- (三) C○○三政府資料中之辨識者。(例如：身分證統一編號。)

五、 個人資料利用之方式

本網站所蒐集的足以識別您身分的個人資料，本公司將依照蒐集目的之不同，以下列方式進行利用：

(五) 為提供本網站會員如贈品兌換、新產品及新服務介紹等廣告資訊，本公司將利用您所提供之基本資料，傳送相關廣告資訊給您。

六、 個人資料利用之期間、地區、對象

(一) 利用期間：本公司存續期間或依法令之資料保存期間。

(二) 利用地區：除法令另有規定外，本公司僅會基於您授權的範圍，於本網站服務所提供之領域及地區內，依照各該服務目的範圍為作業之必要，利用您所提供的個人資料。

七、 資料當事人之權利

(二)當您的個人資料有變更、或發現您的個人資料不正確時，要求修改或更正。

(三)當蒐集個人資料之目的消失或期限屆滿時，您得向本公司請求停止蒐集、處理或利用及請求刪除您的個人資料。但因本公司執行職務或業務所必須，或依相關法令規定，該等資料不適用於刪除權之行使時，不在此限。

八、 資料正確性之權益影響

Privacy Policy and Personal Data Protection Statement

This website is operated by "Tricore Corporation" (hereinafter referred to as "The Company"). To protect our customers' privacy, the collection, processing, and use of customer data strictly comply with the Personal Data Protection Act and relevant regulations of the Republic of China. 1 、 Scope of Personal Data Protection Statement

8. (093) Property insurance.

14. (152) Advertising or commercial activity management.
15. (181) Other business operations in compliance with the Company's registered business scope or organizational charter.

4 、 Categories of Personal Data Collected

In accordance with the "Specific Purposes and Categories of Personal Data" issued by the Ministry of Justice, the Company collects, processes, and uses the following types of personal data:

1. C001 – Identifiable Personal Information(e.g., name, job title, residential address, work address, home phone number, mobile phone number, mailing and registered address, email address, and any other information that can identify an individual.)
2. C002 – Financial Identification Information(e.g., financial institution account numbers and names, credit card or debit card numbers, personal account numbers, or other financial identifiers.)
3. C003 – Government-Issued Identifiers(e.g., national identification number.)
4. C011 – Personal Characteristics(e.g., age, gender, date of birth, place of birth, nationality, voice, etc.)
5. C091 – Goods or Services Acquired by the Data Subject(e.g., details of purchased goods or services, information on loans or employment related to the data subject.)
6. C093 – Financial Transactions(e.g., transaction amounts, credit limits, guarantors, payment methods, transaction records, security deposits, or other guarantees.)
7. C101 – Commercial Activities of the Data Subject(e.g., business type, goods or services provided or used, business contracts, etc.)

8. C102 – Agreements or Contracts(e.g., agreements related to transactions, business, legal matters, agency arrangements, etc.)
9. C132 - Unclassified Data.(For example: letters, files, reports, or emails that cannot be categorized.)
10. Other personal data collected during your actual interactions with The Company.

5 、 Methods of Personal Data Usage

The Company will use the collected personal data identifiable to you as follows, based on different collection purposes:

- (1) To verify your identity and communicate with you using the basic information you provided.
- (2) To deliver your ordered products to the specified address, sharing delivery information with The Company's partners, including suppliers and logistics providers.
- (3) To process transactions made on this website, providing your financial data to financial institutions.
- (4) To improve the quality of The Company's products and website services, using cookies or similar technologies to record your browsing activities.
- (5) To send promotional information such as gift exchanges, new product and service introductions, using the basic information you provided.

6 、 Duration, Region, and Recipients of Personal Data Usage

- (1) Duration: The period during which The Company exists or as required by law for data retention.
- (2) Region: Unless otherwise specified by law, your personal data will be used within the authorized scope in the areas where this website's services are provided.
- (3) Recipients: The Company, its branches, affiliates, or other organizations that have business dealings or cooperation with The Company.

7 、 Rights of Data Subjects

You have the following rights regarding the personal data held by The Company:

- (1) To inquire, request access, or request a copy of your personal data (subject to necessary costs).
- (2) To request modifications or corrections when your personal data changes or is found to be inaccurate.
